Exhibition selection will be by digital file entry, 300 dpi, and tiff format. Artists (if chosen) are responsible to prepare their artwork for exhibition. Two-dimensional work must be framed and wired. Three-dimensional work must meet space and handling restrictions. No special hanging requirements can be considered due to exhibit area restrictions.

Restrictions: 2-D work cannot exceed 48" in any dimension or 35 lbs hanging weight. 3-D work is restricted to floor or pedestal pieces. Fragile or complex installations cannot be accommodated in the exhibition spaces. Accepted entries must be able to meet the installation requirements prior to the exhibition.

IN ORDER FOR WORK TO BE ACCEPTED for entry into competition, and exhibited (if selected as exhibition piece by judge), the following statements must be completed, signed and witnessed, and **submitted at time of submitting entry for judging:** (Work will not be accepted for judging without both completed, signed statements.):

- 1) **Liability Waiver and Permission for Exhibition/Publishing of Art – see below on this entry form**
- 2) **Talent/Broadcasting Release - see below on this entry form**

LIABILITY WAIVER AND PERMISSION FOR EXHIBITION/PUBLICATION OF ART

I, _____, being of legal age (18 or older), allow the Maricopa County Community College District ("MCCCD") to exhibit my original artwork at the Herberger Theater on April 30, 2009 ("Exhibit"), and/or to publish the artwork in digital or in hard copy format. I understand and acknowledge that I will not be compensated for participating in this Exhibit and that the contribution of my artwork for the Exhibit is wholly voluntary.

In consideration of MCCCD's agreement to display my artwork and participate in this Exhibit, I agree as follows:

- 1) individually, hereby release, acquit and forever discharge the MCCCD and its agents, officers, officials, employees, and volunteers (in their official and individual capacities) from any and all responsibility for any and all damages or losses including destruction, loss, or theft of any items that I may exhibit during the display period, transportation to/from the display site, or during installation or removal of the Exhibit.
- 2) I acknowledge that the MCCCD is not providing any form of insurance for my artwork displayed in the Exhibit and I will purchase insurance, at my own expense, to cover my artwork, if I so desire.
- 3) In signing this Waiver and Release Agreement, I hereby acknowledge and represent that I have read this entire document, that I understand its terms and conditions, that by signing it I am giving up substantial legal rights I might otherwise have, that it is a binding agreement, and that I have signed it knowingly and voluntarily.

TALENT AND BROADCAST RELEASE FORM

INSTRUCTIONS:

This form is required to be submitted with all Art Competition entries. It will be used if your entry is selected for exhibit in the event indicated above. Section Two, paragraph 3: Print the title of your artwork where indicated.

SECTION ONE

I authorize the Maricopa County Community College District, and those acting within its authority, to, at no charge to:

- record my participation, appearance, and exhibited artwork on video tape, audio tape, film, photograph or any other medium.
use my name, likeness, voice, and biographical material in connection with these recordings.
copy the recording, in whole or in part and distribute it, including through podcasts on the Internet, solely for educational purposes by MCCCD, and those acting under its authority, as they deem appropriate.

SECTION TWO

1. In addition, I authorize the Maricopa County Community College District, and those acting under its authority, to broadcast my appearance or event participation on Maricopa Colleges Television ("MCTV") facilities in Maricopa County and on any television stations licensed to MCTV. None of the stations are commercial stations. The number of broadcasts will be (to be determined by MCTV scheduling) during the 12 months following the date of my appearance. MCTV may edit the recording of my appearance or event participation to meet time requirements and may play such recordings in whole or in part to meet its schedule. MCTV will cease using any edited recording upon my objection to it in writing. MCTV may use my name, photograph, biographical information, short excerpts of my appearance, and artwork (see No. 3 below) for promotional use without my inspection or approval of the finished product.

2. I understand that I will not receive any compensation for the distribution of my appearance or event participation through MCTV. I also understand that MCTV is not obligated to broadcast or distribute my appearance or event participation, and that any use that MCTV may make of my appearance or event participation is at its sole discretion.

3. I am sole owner of the intellectual property or artwork, "Work," that will be displayed. The name of the Work that I own is: (TITLE OF ARTWORK) . As the owner, I give MCTV a nonexclusive license to use the Work or excerpts of the Work, for broadcast on MCTV at no additional cost beyond any fees that the MCCCD has paid or will pay me in association with my Work.
